

Thank you for your interest in the Maitland Regional Art Gallery Artist Bursary. Application Guidelines and Terms and Conditions are below:

TERMS & CONDITIONS

KEY DATES

- Monday 1 March 2021, applications open
- Wednesday 31 March 2021, applications close

BURSARY

- Monetary bursaries are available as part of the MRAG Artist Bursary with a one-off payment of \$5,000 per artist or \$3,000 per artist collective AUD (no GST) to each successful applicant
- The Maitland Regional Art Gallery (MRAG) will make the \$5,000 or \$3,000 (no GST) payment to the selected artists or collectives following the announcement

PURPOSE OF FUNDING

- In accepting the bursary, the applicant agrees that it be used only for the purpose specified in the application
- The funding is intended to support: the purchase of new or upgraded equipment, refurbishments, materials, research opportunities or promotional initiatives
- No presentation outcomes are expected, however the applicant agrees to provide a one page written report (max 500 words) describing how the bursary has been applied at a later date and, to the best of their ability, be available should digital, educational or promotional opportunities arise

WHAT TO SUBMIT

- Artist / Collective CV
- Proposal, no longer than 2 A4 pages, addressing what the funds will be used for and how it will benefit your practice / collective
- A URL link to supporting material, containing up to 6-high resolution images or videos (Adobe RGB, JPEG/ TIFF, 300dpi) and full caption details including: title, creation date, creation place, medium, dimensions (cm), photographer
- Applicants acknowledge all information provided in their application may be used by MRAG for purposes including, but not limited to, education, publicity, and promotion
- Applicants agree that the works of art provided in support materials are original and do not infringe the copyright, moral rights, or other rights of any third party

APPLICATIONS GUIDELINES

- Submissions must be emailed to MRAG by Wednesday 31 March 2021 at 1700 AEDT.
- Artists and collectives must meet the eligibility criteria, as follows:
- Over 18 years of age at Wednesday 31 March 2021 Practising visual artists (including individuals, collectives/studios)
- Connected to the Maitland Local Government Area artists must be living within a 100km radius of the Maitland LGA and collectives must be living within the LGA
- Application is limited to one application per Artist, Collective/studios

SELECTION PROCESS

- An internal panel will assess selection for the bursary, including the MRAG Director and Senior Curator, and two nominated representatives from the MRAG Members Committee
- Panel assessment is final, and no correspondence will be entered into
- Application outcomes will be notified in writing
- Selected artists and collectives agree to any embargo applicable to the official announcement of successful outcomes.

ACKNOWLEDGEMENT OF BURSARY

Where applicable, the applicant agrees to acknowledge the Maitland Regional Art Gallery Members and Maitland Regional Art Gallery Artist Bursary in any material produced in relation to the purpose outlined in their application.

Any work exhibited in direct result of the funding must acknowledge the Maitland Regional Art Gallery Members and Maitland Regional Art Gallery Artist Bursary.
